Pursuant to Article 58 of the Statute of the University of Belgrade - Faculty of Forestry no. 01-1/36 of 14 March 2019, and in response to the proposal of the Commission for the Second Degree of Studies (Commission for Master's Degree Studies) no. 01 - 4986/1 of 10 May 2022, and after a public debate and a positive decision regarding the proposal of the Council of the Department of Forestry and Nature Protection no. 06-5593/1 of 20 May 2022, the Council of the Wood Technologies no. 07-5568/1 of 19 May 2022, the Council of the Department of Landscape Architecture and Horticulture no. 08-5558/1 of 19 May 2022 and the Council of the Department of Ecological Engineering in the Protection of Soil and Water Resources no. 09-5545/1 of 19 May 2022, the Teaching and Scientific Council of the Faculty at its session held on 25 May 2022, passed the following

RULE BOOK

ON AMENDMENTS TO THE RULEBOOK ON THE CONDITIONS OF ENROLLMENT AND CRITERIA FOR RANKING CANDIDATES FOR ENROLLMENT IN MASTER'S DEGREE STUDIES OF THE STUDY PROGRAM "FORESTRY AND NATURAL RESOURCES MANAGEMENT",

No. 01-2/83 of 22 July, 2020

Article 1

The rulebook on the conditions of enrollment and criteria for ranking candidates for enrollment in master's degree studies of the study program "FORESTRY AND NATURAL RESOURCES MANAGEMENT", no. 01-2/83 of 22 July 2020, Article 8 is amended as follows:

"The order of candidates for enrollment in master's degree studies is determined on the basis of: the grade point average in previously completed studies, length of study of the previous level of study, compatibility of the study programme with the program "Forestry and Natural Resources Management", motivation letter and additionally achieved results:

- 1. Grade point average at the previous level of study maximum 10 points;
- 2. Length of study of the previous level of study maximum 10 points;
- 3. Compatibility of the study programme maximum 10 points;
- 4. Motivation letter maximum 30 points;
- 5. Additionally achieved results maximum 40 points;

When being ranked, the candidate can score a maximum of 100 points."

Article 2

After Article 8, a new Article 9 is added to read as follows:

"The length of study of the previous level of study is scored as follows:

- 1. for candidates who have completed a three-year undergraduate study programme under the Bologna system (180 ECTS):
 - 10 points for the length of study up to 3 years;
 - 8 points for the length of study up to 4 years;
 - 6 points for the length of study up to 5 years;
 - 4 points for the length of study up to 6 years;
 - 2 points for the length of study up to 7 years;
 - 0 points for the length of study over 7 years;
- 2. for candidates who have completed a four-year undergraduate study programme under the Bologna system (240 ECTS):
 - 10 points for the length of study up to 4 years;
 - 8 points for the length of study up to 5 years;
 - 6 points for the length of study up to 6 years;
 - 4 points for the length of study up to 7 years;
 - 2 points for the length of study up to 8 years;
 - 0 points for a study period of over 8 years;"

Article 3

The present Articles 9, 10 and 11 become Articles 10, 11 and 12.

Article 4

This amendment to the Rulebook enters into force on the day following the day of its adoption, i.e. its publication on the Faculty's website.

The decision should be submitted to: the Commission for the Second Degree of Studies, the Service for Teaching and Student Affairs, the Secretary of the Faculty, all departments, the Dean, and the Record Office.
