**Forestry and Natural Resources Management**

The study programme of the Master's Degree Studies of the Faculty of Forestry lasts for two years (four semesters) in which students acquire 120 ECTS credits.

**GENERAL CONTEST REQUIREMENTS**

The first year of master's degree studies of the study programme Forestry and Natural Resources Management in the English language can be enrolled by a person from the Republic of Serbia or abroad who has completed undergraduate studies in the field of forestry or in another related field of education within the educational and scientific field of technical and technological sciences and has earned at least 180 ECTS credits.

**SPECIAL CONTEST REQUIREMENTS**

As proof of English language proficiency, the candidate must hold a Cambridge Advanced Certificate in English (CAE) / IELTS - International English Language Testing System, a compatible degree or a completed secondary education in English.

**CRITERIA FOR DETERMINING THE ORDER OF CANDIDATES**

The order of candidates for enrollment in the master's degree studies shall be determined on the basis of the:

1. **Grade point average** - maximum 10 points;
2. **Length of study** - maximum 10 points;
3. **Compatibility of the study programme** with the programme "Forestry and Natural Resources Management" - maximum 10 points;
4. **Motivation letter** - maximum 30 points;
5. **Additionally achieved results** - maximum 40 points, as follows:
  - scientific papers published in journals from the SCI list - number  $\times$  2 points;
  - scientific papers published in journals of national importance or at scientific conferences number of papers  $\times$  1 point;
  - participation in scientific projects - number  $\times$  1 point;
  - professional papers - number  $\times$  0.5 points;
  - awards or recognitions - number  $\times$  1 point;
  - additional scientific or professional training - number  $\times$  1 point;
  - work experience in the professional field of forestry – number of years  $\times$  1 point;
  - work experience outside the professional field of forestry - number of years  $\times$  0.5 points;

Candidates can score a maximum of 100 points.

**FIRST ENROLLMENT TERM**

Applicants submit applications to the contest **through the Student Service of the Faculty from 10:00-13:00**

**Registration of candidates - from October 12 to November 3, 2025;**

- preliminary ranking lists shall be published - **on November 5, 2025 after 3.00 p.m.;**
- candidates can file complaints **on November 7, 2025 at 10.00 a.m.** - response to complaints shall be given **on the same day by 3.00 p.m.;**
- **the final ranking lists** shall be published - **on November 10, 2025 by 3.00 p.m.;**
- **enrollment of candidates** - **on November 11 and 12, 2025;**
- The number of vacancies for the second enrollment period shall be announced **on November 14, 2025;**

**A candidate who has acquired the right to enroll and does not enroll within the stipulated deadline shall lose the right to enroll and the next candidate shall be enrolled in his/her place according to the established order of candidates.**

**SECOND ENROLLMENT TERM**

If there are vacancies, at the proposal of the Faculty, the Senate will approve a second deadline for enrollment at this level of study.
